ONE YEAR LIMITED WARRANTY

Watkins Manufacturing Corporation warrants to the original consumer purchaser at retail, that the components (except for the Sony FM/AM Portable CD Player) of the SpAudio music system will be free from defects in material and workmanship for a period of one year from the original purchase at retail.

EXTENT OF WARRANTY

This warranty extends only to the original consumer purchaser of the SpAudio music system when purchased from a Factory Authorized Service Agent and originally installed within the boundaries of the United States of America and Canada, and terminates upon any transfer of ownership by the original consumer purchaser prior to the expiration of the warranty period.

WARRANTY PERFORMANCE

In the event of any malfunction or defect covered under the terms of this warranty, a Factory Authorized Service Agent of Watkins Manufacturing Corporation will repair or replace the SpAudio music system or components (except for the Sony FM/AM Portable CD Player) found to be defective. To obtain service, contact the Factory Authorized Service Agent that sold you the SpAudio music system. There will be no charge for parts, labor, or for the freight costs necessary to repair the SpAudio music system. In some cases, reasonable travel expenses for the Service Agent may be assessed if you live beyond the normal servicing area of the Factory Authorized Agent.

Watkins Manufacturing Corporation maintains an extensive service network within all fifty states and Canada. In the event the original consumer purchaser should be unable to either obtain service, or satisfactory service, from a Factory Authorized Service Agent, notify the Customer Service Department at Watkins Manufacturing Corporation. Written notice of any malfunction or defect must be given within ten (10) days of the time the malfunction or defect is discovered, and must be accompanied by a copy of the original consumer purchase receipt of the SpAudio music system, which shows the date of purchase.

Notice must be given to Watkins Manufacturing Corporation, 1280 Park Center Drive, Vista, California 92083, Attn: Customer Service Manager. Watkins Manufacturing Corporation reserves the right to inspect the malfunction or defect on location.

ACTS INVALIDATING WARRANTY

This warranty is void if the SpAudio music system is subjected to alteration, misuse or abuse, or any repairs on the SpAudio music system are attempted by anyone other than a Factory Authorized Service Agent of Watkins Manufacturing Corporation. Misuse and abuse includes any operation of the SpAudio music system other than, in accordance with, the Watkins Manufacturing Corporation's printed instructions.

DISCLAIMERS

Watkins Manufacturing Corporation shall not be liable for loss of use of the SpAudio music system or other incidental or consequential costs, expenses or damages. Any implied warranty including, but not limited to, warranties of merchantability and of fitness for a particular purpose, shall have a duration equal to the duration of the applicable warranty stated above. Under no circumstances shall Watkins Manufacturing Corporation, or any of its representatives, be held liable for injury to any person, or damage to any property, however arising.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so, the above limitations or exclusions may not apply to you.
